I received a consult to facilitate discharge of the patient from the hospital. Kelly Pipkin RN notified me that the patient came here from Sun Belt Skilled Nursing Facility with rectal bleeding and ^{LE error} Sun Belt refused to accept the patient back. I phoned Sun Belt re: this, and spoke to Rachel RN (nursing supervisor). Rachel confirmed the above + added that the patient's son displayed inappropriate behavior when visiting his mother @ Sun Belt, including kissing his mother on the lips mid way "you don't kiss your mother" lying fully on top of his mother kissing her on the lips with his mouth open and disimpacting her (inserting a finger into the rectum and digitally breaking up and removing stool), yelling at the nursing staff. Rachel RN stated all the above were witnessed in her facility. Rachel RN stated she + her staff felt very threatened by + scared of the son, who makes health care decisions for the patient. Rachel indicated she had trespassed the son based on the above from Sun Belt, + had reported the above to Donna abuse/Donna. Following this phone conversation with Rachel RN I returned to the nursing station @ ORMC Emergency Dept, where Kelly Pipkin RN reported witnessing the son kissing his mother on
